

General Director of Goodseed International

Goodseed International is an equipping ministry specializing in worldview evangelism and discipleship. GoodSeed curriculum was originally designed for those with no knowledge of the Bible, but experience has shown that whether a person has been a believer for three days or 33 years, these resources have been instrumental in building confidence in the Word and boldness in faith. Prior to GoodSeed, John worked for 25 years with a ministry that took him to the most remote people groups on planet earth. Ten of those years he based his family in Papua New Guinea. The Laurentian Leadership Centre, is an Ottawa-based, live-in, extension program for upper-year university students focusing on public policy. She has previously served as director, law and public policy, for the Evangelical Fellowship of Canada and Executive Director of the Christian Legal Fellowship. She is one of the lead developers of a proposal for a law school at Trinity Western University.

In 1986 Buckingham received her LL.B. from Dalhousie University. She clerked for the Federal Court of Canada has been called to the bar and practiced law in Nova Scotia and Ontario. Buckingham completed her LL.D. at the University of Stellenbosch, South Africa in 1998, with a dissertation comparing religious freedom in Canada and South Africa. She has numerous academic publications on religious freedom, and has most recently published a book on the history of religious freedom in Canada, *Fighting over God*.

Founder & President, Rocklinc Investment Partners Inc.






Lorraine Hopkins, PFP, Christian Financial Counselor
